Once the entry is submitted, changes to the artwork will no longer be accepted. You cannot withdraw your entry and submit a new one. 1.9_To be eligible, entries must be completed and received on or by the closing date of the draw. 3.1_The thema of the contest is ANTIFEMINISM x HAGAKURE Coupling Tour 2007 in America. The contestant must produce an original artwork related to that thema to be eligible. 3.2_Submissions will only be accepted as .jpg files at 72 dpi. Its size must be 800x610 pixels maximum and it must not exceed 150ko. 3.3_VERY IMPORTANT:The contestant must make sure to have the 300 dpi version of the submitted artwork. It will be required to realise the prize. 3.4_The submitted artworks can be hand drawn (or painted), computer graphics (CG), or a combination of different arts. If your work is not CG, please send a scan (or scanned photograph) of your entry. 3.5_The artwork must not include elements that could be conceived as copyrighted or trademarked material belonging to any third party. 3.6_The pictures of ANTIFEMINISM and HAGAKURE authorized to be used in the contest are only the five (5) pictures and the logo of each band display by the administrator of the GUERILL'ART!'s forum in the post related to ANTIFEMINISMxHAGAKURE Coupling Tour 2007 in America - FAN'ART Contest.
